



## VERO INTERNATIONAL SOFTWARE LICENSE AGREEMENT

This is a legal and binding agreement between the end-user customer ("Customer") and Vero International Software UK Ltd, ("Vero"). BY OPENING THE SEALED DISK (CD) PACKAGE OR RUNNING THIS PROGRAM, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT.

Vero hereby grants to the Customer a non-transferable and non-exclusive license to use one copy of the Vero software product acquired with this License ("SOFTWARE") on any single computer, provided the SOFTWARE is in use on only one computer at any time. The SOFTWARE is considered to be "in use" when it is loaded into any form of memory; temporary or permanent (such as RAM, CD-ROM, hard disk) of the single computer.

The SOFTWARE may be installed on a network server for use on an internal network, on the same site, provided that the Customer has acquired a license for every single computer on which the software is installed (either in memory or hard disk). A single SOFTWARE license may not be used to share the use of the SOFTWARE on more than one computer.

**COPYRIGHT** - The SOFTWARE and included user documentation and related material are the exclusive property of Vero or its suppliers. The Customer acquires no title, right or interest in the SOFTWARE other than the license rights granted herein. The Customer may not copy the user documentation or written materials accompanying the SOFTWARE. One copy of the SOFTWARE may be made solely for backup or archival purposes. The Customer shall not remove from the SOFTWARE any trademark, trade-name, copyright notice or any other notice.

**LIMITED WARRANTY** - Vero warrants that the SOFTWARE will perform substantially in accordance with the accompanying user documentation for a period of 90 days from the date of receipt. Any implied warranties on the SOFTWARE are limited to 90 days.

**OTHER WARRANTY EXCLUSION** - Vero DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH RESPECT TO THE SOFTWARE, THE ACCOMPANYING PRODUCT MANUAL(S) AND WRITTEN MATERIALS, AND ANY ACCOMPANYING HARDWARE. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS.

**LIMITATION OF LIABILITY** - Vero or its Suppliers gives no warranties with respect to the Program licensed hereunder and all implied warranties including any warranty of merchantability and fitness for purpose are hereby excluded. IN NO EVENT WILL VERO OR ITS SUPPLIERS BE LIABLE FOR INDIRECT CONSEQUENTIAL INCIDENTAL OR SPECIAL DAMAGES EVEN IF VERO HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND THE MAXIMUM LIABILITY OF VERO SHALL BE LIMITED TO REFUND TO THE CUSTOMER OF THE PRICE PAID BY THE CUSTOMER FOR THE SOFTWARE.

**SECURITY** – The SOFTWARE is supplied to the Customer solely for the Customer's use and the Customer should take all reasonable precautions to ensure that the Customer or its staff do not make the SOFTWARE available to any third parties without the written permission of Vero. Furthermore, it is recommended that the Customer insures the SOFTWARE for its entire value against damage or loss from fire, theft or accidental loss as Vero may require the Customer to pay the full value of the SOFTWARE for its replacement.

**TRANSFER** – The license is non-transferable either by sale, leasing, sub-licensing, loan or other means to any third party without the express written permission of Vero.

**UPDATES** – If the SOFTWARE is an update of another product the Customer may use the SOFTWARE solely in conjunction with the said product and cannot be separated for use on a separate computer

**TERMINATION OF THE LICENSE** - The license granted hereunder may be revoked and terminated forthwith by Vero by written notice to the Customer if any of the following events occur:

- in case of breach by the Customer of any provisions hereof
- in case of non payment by the Customer in due time of any sum due from the Customer in consideration of delivery and licence of the Program
- Customer shall refrain from any further "use of the software" and lose any entitlement to upgrades under any maintenance agreement for the SOFTWARE, that the Customer may have.

Upon termination of the license granted hereunder the right to take any legal action necessary to recover any damages incurred by Vero.
